



Memorandum of Understanding

This Memorandum of Understanding, hereinafter referred to as the “MOU”, is entered by Research Synergy Foundation hereinafter referred to as “First Party”, located at Komplek Sinergi Antapani, Jl. Nyaman 31, Bandung 40291, Indonesia, and Universitas Persada Indonesia Y.A.I hereinafter referred to as “Second Party”, located at Jl. Diponegoro No. 74 Jakarta 10340, Indonesia. The main objective of MOU is to recognize common interests in developing bilateral relationships and convinced that cooperation between both institutions contributes to the research ecosystem of knowledge sharing, international conferences, and international journals.

I. PURPOSE & PROGRAM

In particular, this MOU is intended to:

A. Research Development and Collaboration

- Develop collaborative research programs or endeavors that are vital in solving plaguing issues and problems in society.

B. International Research Publication

- Establish partnership in assisting to both parties in publishing quality research outputs in internationally acclaimed journals.

C. Research Enhancement Program

- Collaboratively develop mechanisms in enhancing the research capabilities of neophyte researchers.

D. Research Conferences and Forums

- Shall establish a partnership in organizing research conferences and forums to foster the research capacities of researchers and institutions and boost the creation and diffusion of new knowledge.

II. GENERAL PROVISION

- This MOU is a general statement of both parties to help each other in different academe and industry fields. Both parties must agree on specific terms and conditions of each program mentioned above through MOA after signing the MOU.
- This MOU shall be effective upon the signature of the First Party and Second Party authorized officials.

Details of the implementation of any particular activity resulting from this MOU shall be negotiated between the two institutions as such specific cases arise. This MOU will be valid for five (5) years on the date it has signed by both Parties upon completion of the signatures. It is subject to revision, renewal, or cancellation by mutual consent upon written notice given six (6) months before the termination date becoming effective provided. However, that termination of the MOU will not affect the conditions or access to activities/events for students or faculty who are participating in the activities at the time of termination. Any changes under this clause will be subject to the terms of any specific agreement. By signing below, the parties agree to be bound by the terms of this MOU.
